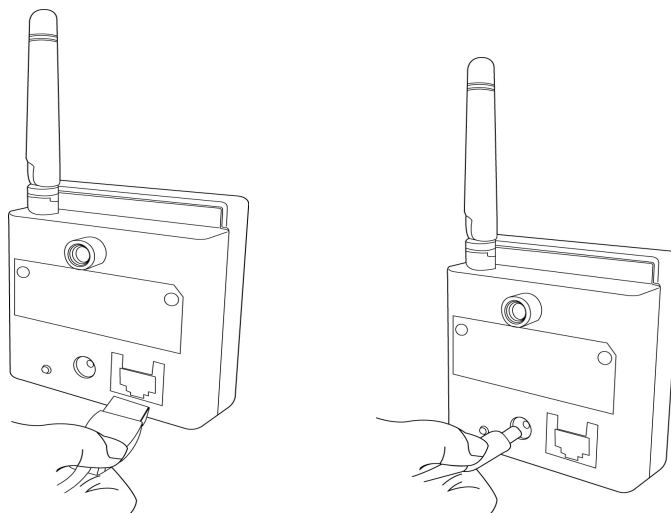

| LED Name | Description |

| Power  | When the camera is powered on, the power/cloud LED will stay solid for 30 seconds while the camera initializes. The LED will then start to flash, which indicates the camera is connecting to the cloud. When it stops flashing, the camera is ready for access over the cloud. |
| LAN  | The LAN LED indicates whether there is network activity in the local area network. |

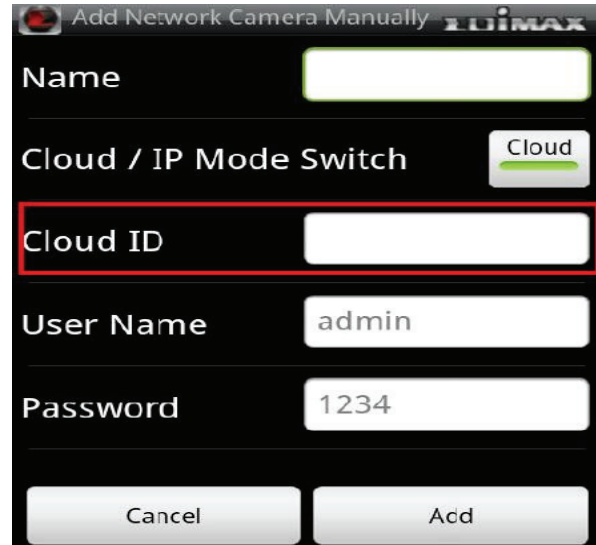
GETTING STARTED

1. Connect the network camera's "LAN" port to a router or switch's "LAN" port with an Ethernet cable, then turn on the network camera. After installation, the Power LED will light up for 30 seconds while the camera initializes. Then, the LED will flash for 10 to 15 seconds while connecting to the cloud. The power LED stops flashing when connected to the cloud.



Configuring the Smartphone Surveillance Software:

2. Please go to the Apple app store or Android Google market to download “EdiView”. Enter the Cloud ID, Username and Password to finish the installation.



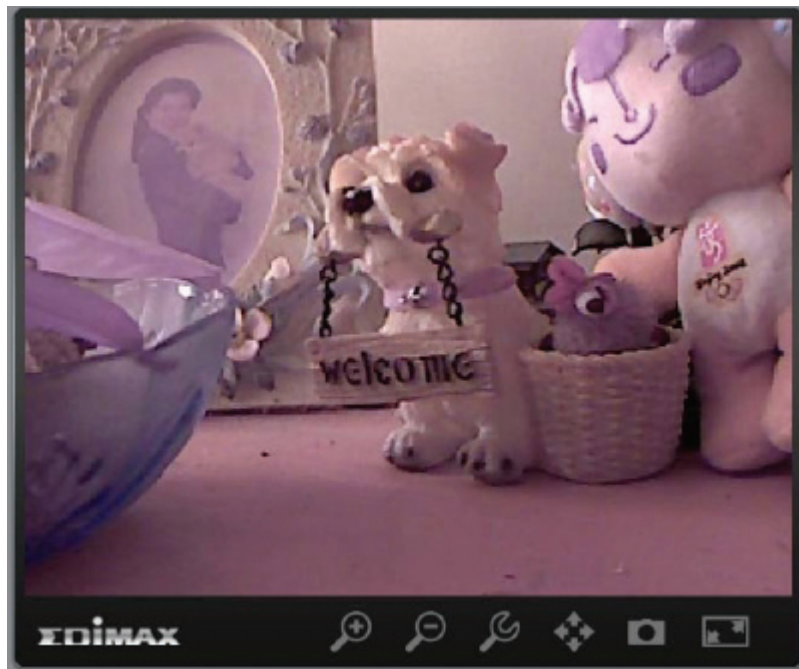
Note: Each network camera comes with a Cloud ID card which contains the camera's Cloud ID (MAC address), username and password.

3. To access myedimax.com, enter [Cloud ID].myedimax.com into the web browser's address bar, where [Cloud ID] is the twelve character Cloud ID of the network camera, found on the included Cloud ID card. When myedimax.com loads, enter the camera's password. The default password is 1234



- Click OK to continue. The network camera can now be controlled from the applet.

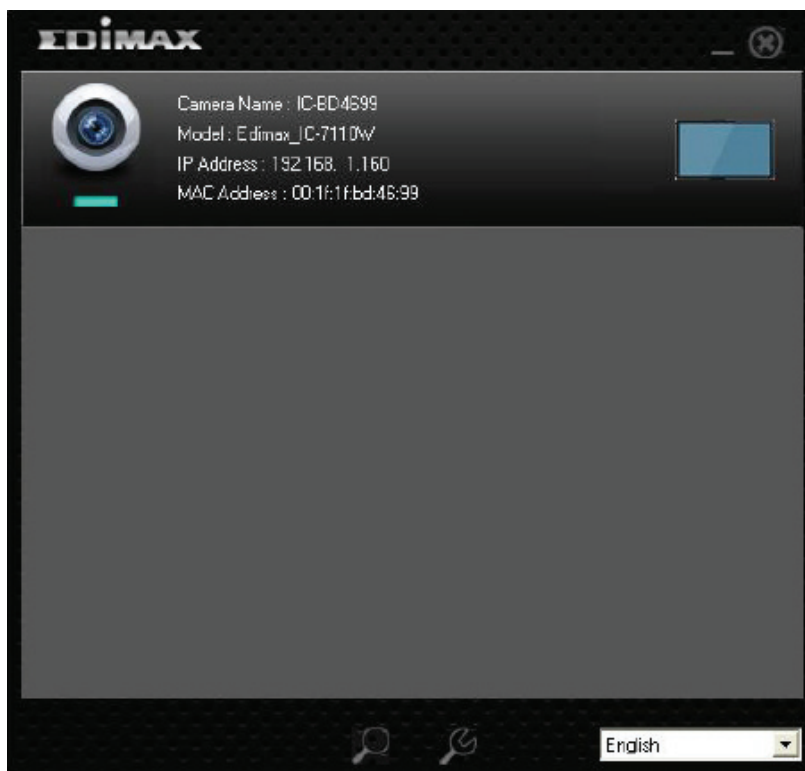


Configuring the EdiView Finder Utility

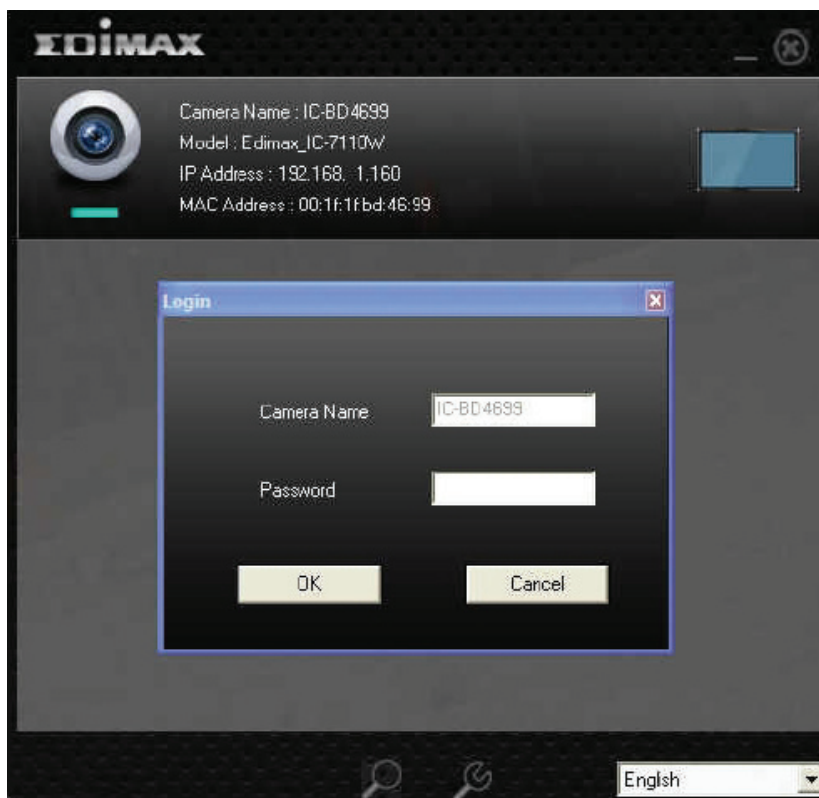
- Insert the Edimax CD into your CD-ROM drive and click “Setup Utility” to install the utility software. The setup wizard will guide you through the setup process.



Note: MacOS utility is supported within the CD-ROM EdiView Finder Utility.

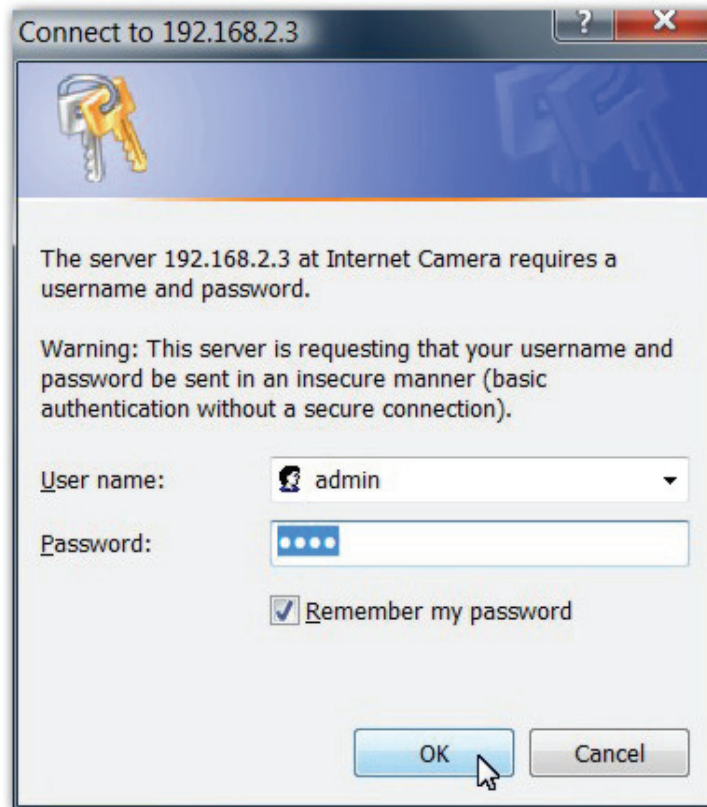


6. After EdiView Finder is launched, all cameras found on the LAN are displayed. To connect to a specific camera, double-click the camera listing. Enter the password for the camera (default: 1234) in the login dialogue.

7. Launch IE and type the IP address of the camera (found by running EdiView), and enter “admin” in the username field, and “1234” in the password field to log in.



8. Once you are logged in, the browser may prompt you to install ActiveX. If it does, click “Install ActiveX Control...” to continue.
