

KORG's "Korg Vintage T-Shirt Giveaway Contest"

Official Rules

NO PURCHASE NECESSARY. The **KORG Vintage T-Shirt Giveaway Contest Giveaway** ("Promotion") takes place beginning at 3:00 PM EST, April 1st, 2014 and ends at 4:59 PM EST, April 30th, 2014 (the "Promotion Period"). The Promotion is sponsored by Korg USA, Inc., 316 South Service Road, Melville, NY 11747 ("Sponsor"). All federal, state and local laws apply. Void where prohibited.

Eligibility: The Promotion is open to all residents of the 50 United States and Washington D.C. who are at least 18 years old, have reached the age of majority in their state of residence, and who have internet access at the time of the Promotion Period. Selection: Winners will be randomly selected from all eligible entries on the last business day of the contest period. Odds of winning will depend upon the number of eligible entries received during the Promotion Period.

Prizes: There will be ten prizes awarded upon completion of the Promotion Period, consisting of KORG Vintage T-Shirts, **valued at \$19.99/ea.** Prizes will be awarded as described. No substitution or transfer of prizes, except at the sole discretion of the Sponsor, if the advertised prize becomes unavailable.

Notification of Potential Winners: A post will be made on Korg USA's Facebook page on April 30th at 5:30 PM, EST, announcing our winners. A Potential Winner will also be contacted via Direct Message upon completion of the Promotion. The Potential Winners are required to contact the Sponsor within 5 business days of the drawing. Prizes will be shipped to winners via FedEx or UPS GROUND within two weeks of the end of the Promotion Period.
