Your Smart Ready host system is backward compatible with all traditional and previous versions of Bluetooth devices; however, the devices will function as what they are without the full benefits of the Bluetooth v4.0 LE and EDR.
- Please review the documentation that comes with your Bluetooth device, or consult with your device vendor's Technical Support for any specifics regarding your Bluetooth device.

• Run CSR Harmony Bluetooth Stack by double clicking the Bluetooth icon on your system tray or desktop.



 Make sure your Bluetooth device is in pairing mode. Press "File" pull down menu, select "Add Device", and then select from the pull down menu "Phone", "Computer", "Audio/Video Device", Imaging Devices", "Keyboard/Mouse", or "All" if it's not listed.
