




MOUNTING AND ADJUSTMENT

First remove the clear protectors from the TEMPERBOND™ Suction Cup and the Sticky Grip Pad.

Clean the desired mounting with water or alcohol as necessary and let dry.



Move the Suction Lever into the raised position. Position the mount on the flattest surface possible for best suction. Press down on the base firmly, then move the suction lever fully down to secure the mount to your dash.



PHONE MOUNTING

Make sure your phone is free from dust or oils.



PHONE AND MOUNT REMOVAL


The phone is most easily removed from the dock using a twisting motion.

To release the mount from your dash lift up on the Suction Lever, then pull up on the release tab. The longer the mount is on the dash the harder it may be to remove.

IMPORTANT NOTE:

After time the Sticky Grip Pad and the TEMPERBOND™ Suction Cup can become contaminated with dust and affect its performance. Simply clean with water and let dry to restore optimal performance.

There may be a ring left on the dash from the mount. Clean with water as necessary. On padded dashes the mount may leave a slightly raised area. This should go away in a few days.



LIMITED WARRANTY

Limitation on Warranty and Claims. SELLER WARRANTS THAT THE GOODS SOLD AND DELIVERED BY THE SELLER TO THE BUYER SHALL BE FREE FROM DEFECTS IN WORKMANSHIP AND MATERIAL UNDER NORMAL USE AND SERVICE FOR A PERIOD OF ONE (1) YEAR FROM THE DATE OF DELIVERY. THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, WHETHER STATUTORY OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Seller's liability for breach of warranty shall arise only upon the return of the defective parts at the buyer's expense after notice to the seller of claimed breach and shall be limited to furnishing a like quantity of such goods free from such defects or, a the seller's option to refund the purchase price. Notice to the seller of claimed defects discoverable by inspection must be given within ten (10) days after receipt of shipment. In no event shall the seller be liable to the buyer for indirect, incidental, collateral or consequential damages of any kind. The buyer indemnifies the seller, its successors and assigns from and against any and all losses, damages and expenses (including reasonable attorney's fees) which the seller may sustain or incur as a result of any claim of negligence, breach of warranty or strict liability in tort in connection with the use of the goods furnished hereunder, except such as may be wholly caused by the negligence of the seller.
