Return this completed form, including the serial number of the plasma(s), along with a copy of your entire unaltered invoice with the purchase price circled. **IMPORTANT:** You must cut out and include the original label from the plasma carton, which includes, the UPC code of the plasma, model number and serial number, or your claim cannot be processed.
3. Offer valid for purchase made from November 1, 2006 to and including March 31, 2007. All claims must be postmarked by April 30, 2007.
4. This offer is available only to the end user and original purchaser. No claims from re-sellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be accepted or acknowledged.
5. Product must be new and un-used. No B-Stock Product allowed. Must be authorized US Product.
