Introduction

The *USB 3.0 4-Port Hub* is designed to support USB 3.0 equipped PC computers and expands USB 3.0 connectivity to your computer.

Key Features and Benefits

- Adds 4 USB 3.0 ports to your system
- Works with high-bandwidth USB 3.0 devices, such as external hard disks, high resolution webcams, camcorders, video surveillance cameras, digital video cameras, multi-channel audio and more
- Compliant with Universal Serial Bus 3.0 Specification
- Supports simultaneous operation of multiple USB 3.0/2.0/1.1 devices

System Requirements

- Desktop or notebook computer with an available USB port (USB 3.0 recommended)
- Windows® 8 (32-/64-bit) / 7 (32-/64-bit) / Vista (32-/64-bit) / XP (32-/64-bit) / Server 2003 & 2008 (32-/64-bit) / Server 2008 R2
- Mac OS® X v10.8 or later

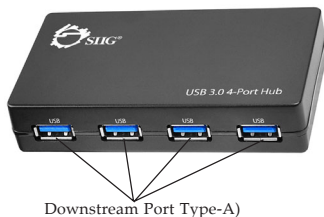


Figure 1: Front Layout

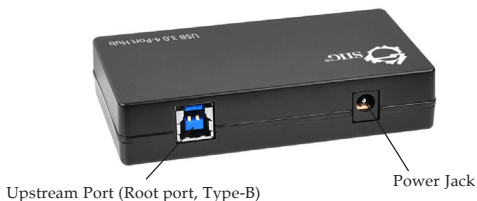


Figure 2: Rear Layout

USB 3.0 Cable Connectors

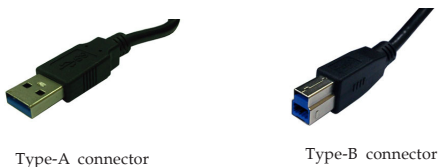


Figure 3: USB 3.0 Connectors

Installation

Important: The *USB 3.0 4-Port Hub* only works at USB 3.0 speed when connected to a USB 3.0 controller. Otherwise it will work as a USB 2.0 or USB 1.1 hub when connected to USB 2.0 or USB 1.1 controller respectively.

In order for the *USB 3.0 4-Port Hub* to work as a USB 3.0 hub, the driver for your existing USB 3.0 host controller has to be properly installed. This hub will automatically be detected and installed when connected to the USB 3.0 port.

1. Connect the **Type-B connector** of the included *USB 3.0 cable* to the **Upstream port (Root Port, Type-B)** of the *USB 3.0 4-Port Hub*.
2. Plug the **Type-A connector** of the included *USB 3.0 cable* into an available USB port (USB 3.0 recommended) of the computer, and the driver will install automatically.
3. Connect the included power adapter into the **Power Jack** of the *USB 3.0 4-Port Hub*, then plug the power adapter into a reliable power source. The power adapter is optional but recommended when all four USB ports
4. The *USB 3.0 4-Port Hub* is ready for use.

To Verify Windows Installation

1. Check in Device Manager.
For Windows 8 / Windows 7 / XP / Server 2003: Right click **Computer** or **My Computer**, click **Manage**, click **Device Manager**.
For Windows Vista: Right click **Computer**, click **Manage**, click **Continue**, click **Device Manager**.
For Server 2008 / 2008 R2: Right click **Computer**, click **Manage**, double click **Diagnostics**, click **Device Manager**.
2. Double click **Universal Serial Bus controllers**, a **Generic USB Hub** should be displayed.

To Verify Mac OS Installation

1. Click the **Apple logo** on the menu bar, then click **About this Mac**.
2. Click **More Info**, then click **System Report**.
3. One **USB 3.0 Hi-Speed Bus** and one **USB 3.0 SuperSpeed Bus** should be displayed under Hardware > USB. See **Figure 4**.

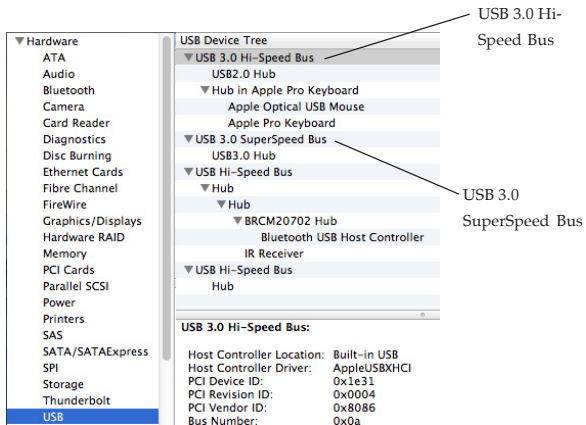
