


## CORSAIR SSD REBATES AT NEWEGG.COM AND NEWEGG.CA

In order to receive your rebate card by mail:

- 1. Purchase a(n) CSSD-V32GB2-BRKT between August 3rd, 2010 and August 31st, 2010 at newegg.ca or newegg.com.
- 2. Go to corsairmemory.rebateaccess.com and enter the promotion number 33116.
- 3. Fill out and print the pre-registration form for this promotion.
- 4. Cut out and enclose the ORIGINAL UPC code located on the back side of the paper insert or product packaging.
- 5. Enclose a copy of the sales receipt or packing slip dated between August 3rd, 2010 and August 31st, 2010 indicating your purchase at newegg.com.
- 6. Mail all of these items to the address noted on the pre-registration form. Submission must be postmarked within 21 days of purchase and no later than September 21st, 2010 in order to qualify. *Do NOT use this form for submittal as it is for instructions and information only.*
