

1. Menu

Opens, selects or exits the OSD menu.

2. Minus "-"

If the OSD menu is on, press to navigate backward through the OSD menu and decrease adjustment levels.

3. Plus"+"/Input

If the OSD menu is on, press to navigate forward through the OSD menu and increase adjustment levels.

If the OSD menu is inactive, press to activate the source button that chooses the video signal input (VGA, DVI, or DisplayPort).

4. OK/Auto

If the OSD menu is on, press to select the highlighted menu item. If the OSD menu is inactive, press to activate the auto adjustment feature to optimize the screen image.

5. Power/Power LED Turns the monitor on or off.

fully powered = white; sleep mode = amber; sleep timer mode = flashing amber.
